I would like to write you and this court in concern and in regard to my present place of stay in VA DOC and stated as a inmate with my new mental, emotional outlook on myself and of future returning to society as a productive citizen

ON 11/6/01 I entered the adult DOC at the young age of 19 as adolescent after going back and forth between Juvenile Detentions and Mental Health Hospitals since the age of 15. I am now 27 and have been in prison for 9 yrs

A troubled state of mind as a ~~juv~~inik with a deluded perception of reality on society etc, with a very precocious attitude toward education and employment led to my incarceration. In fact in retrospect I feel employment and adulthood is the responsibility that come with both intimidated me. This intimidation or fear ultimately led to me giving away my freedom to a prison term of 15 yrs to life for an Armed Robbery on the date of 11-5-01

In prison I have matured and come to the conclusion that I was not a hardened sinister criminal. I simply did not appreciate or respect liberty laws of society and what this country had to offer me, So I lost my freedom due to my indifference or rebellion toward society

I Now having a High School level education and studying college level classes on subjects such as Sociology and Psychology, Both of which have helped broaden my understanding of my self and society as a people. From Psychology I have learned that my diagnosis of Bi Polar Disorder did play a Factor in my Jaded views of society and family, but this disorder does not dominate a person in every case. Further I no longer have a rebellious or schizophrenic mentality, nor an ideology toward my Family or Society, Gov. that derived from my ill mental state and ignorance

With my personal experience and maturity I have learned that while in prison that your environment plays a large factor in who and what you are as well how you relate and react to others in general. I now know that prison is not the place for me or the place I should be.

While in prison I have had a few bad experiences with inmates and staff as well, Ironicly some of the worst from staff or personnel like CO's. For example staff conspiring to deny me medical and dental care for months.

One of the most humbling events was when I was assaulted by a CO with a hand radio as a weapon with he used to strike my head after he accused me of stealing my tray of food, I would not hand over to him

This CO was fired from his job in DOC and due to my knowledge of law I filed a civil action and was found in favor of it by the court which I also have included in this petition as credentials to verify my cause and plight to better myself and reform to the ways of society.

As well as having an interest in Law and Government I have recently just completed the VA, DOC Breaking Barriers Correspondence Course (BRCC) which is a exclusive program for inmates willing and ready to make the corrective steps toward being a productive citizen in society in the near future. (I have enclosed my program Certificate)

c) I am very much ready and willing to return to society as a productive and a honorable citizen, Not having spirituality I feel that I can be beneficial to a religious community. I also plan to start a family.

AFTER 9 YEARS in confinement of DOC which led to my enlightenment of self I am now disenchant, confounded, and disheartened at the prospect of I "a first time felon" doing 15 YEARS for a first time felonies act as a 19 year old adolescent, whom is unable to receive parole after completing more than half my sentence. I am surely rehabilitated and in my 9 YEARS in Prison I have not had any major infractions or charges for violent or sexually deviant behavior

-- upon or directed at Staff personnel or I make as myself as my record and my word do verify

I now would like to request that a commutation or consideration of a time reduction or pardon be given or shown toward my prison term given to me as an adolescent term and not the Maxie Man I am now of 27yrs

If reduction of sentence is made or considered I would request to be placed on probation upon my release to society to the care of my parole officer, ~~██████████~~ so to monitor my behavior and productive transitional phase back into society

I have recently submitted my annual 2 year Petition For Commutation of Sentence or Conditional Pardon to the Governor which was denied for the second time submitted by me.

I Michael Webb now humbly request at the Mercy and Power of this Court room that consideration of commutation of sentence or pardon be granted upon my Prison Term of 15yrs ^{((TO LIFE))} given to me a 19 year old adolescent for a first time Felonial Act.

I would be pleased to help the Courts, you or DOC in any way toward this my agenda I present in this Petition and would thank you and them for any time or concern shown toward this petition
